

Under NEW Idaho tax laws, a single tax payer can donate up to \$500 and receive a \$250 tax credit. A married tax payer can donate up to \$1,000 and receive a \$500 tax credit. This is in addition to the federal and state deductions!

What is the Century Education Foundation?

The CHS Education Foundation supports the efforts of students and staff through financial donations. How are the funds generated?

Staff members must make written grant requests to the CHS Education Foundation Board of Directors. Awards are distributed based on impact on the student educational experience, availability of funds in the line item account for the department to match the request, and the CHS learning goals.
